THE MOST IMPORTANT, OFTEN OVERLOOKED PART OF MEDIATION

A mediation should be client-centric, which means the mediation process should focus on the clients.

Mediators rarely do so.

Instead, mediators often isolate the clients and talk directly to the lawyers, perhaps never even meeting the clients.

This is a mistake - clients are consumers of services, and the best businesses have become very customer-focused, realizing that the product and the experience of buying the product are part of why the customer buys from them and not from someone else. Think of the Amazon experience v. mall shopping during the holidays.

Clients bring this expectation to legal services - the product is the result they seek, and the process to reach that result is their experience. They expect a good experience.

Litigation, which is of course adversarial, is the experience clients must suffer through to get the result. A good mediator creates a good experience for the clients. This means involving them in the mediation, in the right ways, such as by helping them understand the process, giving them a voice, and helping them understand what is a fair outcome in the case. 
Attorney Kriesen is the founder and principal of Kalon.
